This presentation aims to paint a picture of children's palliative care now and into the future. The session will recognise the changing population and epidemiology, combined with the changing expectations of children's palliative care in the UK, it will explore developing collaboration and partnership with the adult sector and will include "up to the minute" information about how the children's palliative care sector is responding to the findings of the Commission on the Future of Hospice Care.
