We strongly support the proposal to allow the courts to consider dignity when interpreting the rights in the Bill. It is the essence of palliative and end of life care to affirm and maintain the dignity of each person in the face of serious illness and dying. No matter whether they have hours, days, weeks or years left to live palliative care aims to maximise wellbeing. As Dame Cicely Saunders, the founder of the modern hospice movement said:

" You matter because you are you, and you matter to the end of your life. We will do all we can not only to help you die peacefully, but also to live until you die."

Everyone dies. Everyone loses people they care about. Everyone is deeply affected by these experiences. Everyone has a story about the palliative and end of life care that made the worst of times more bearable. Or a story about a failure of communication, or a lack of compassion and dignity when it was needed most.

Death, dying and bereavement are the most universal human experiences. Over 60,000 people die in Scotland each year, and this is projected to rise significantly. Almost one-third of the people being cared for in a Scottish acute hospital ward today will have died within 12 months . 72% of UK adults report having been bereaved in the last five years . Over 50% of all children in Scotland are bereaved of a parent, sibling, grandparent or other close family member by age 8 and this rises to 62% by age 10.

How Scotland responds to these experiences are a true litmus test of our values and a test of how effectively as a nation we put those values into action.

We would like the interpretative provision to include the United Nations Report of the Human Rights Council Thirty-first special session (24 August 2021) Forty-eighth session (13 September–11 October 2021), Resolution 48/3 calling on member states to ensure non-discriminatory access for older people to palliative care.

Our test for considering the effectiveness of the Bill is whether it will enhance focus on ensuring that people at the end of life have their rights respected, their wellbeing and dignity affirmed and maintained. For example, will people in Scotland be sure that at the end of their life they will get timely access to care and treatment to manage distressing symptoms? Will public bodies recognise and understand a clearly articulated duty to ensure systems, processes and resources are in place to achieve this end.

There is evidence that some groups experience less good access to palliative care or have less positive experiences of that care. These groups include: prisoners, people who are homeless, travelling people, LGBTQI+, BAME, very old people, people experiencing financial hardship.

We have considered the lengthy consultation document which gives a sense of the technical legal complexities which need to be taken into account in choosing the specific model of incorporation. The proposal appears logical.

Participation arrangements need to take account of the particular challenges faced by people with serious, life limited advanced illness. The phrase "lived experience" is problematic in relation to end of life care. That said there is evidence that people facing the end of life, and their family carers, appreciate opportunities to share their perspectives and inform decision making.

Assuming it is not possible to legislate to treat "dying" as a protected characteristic we would like to see specific mention of older people in the equality provisions. Palliative and end of life care is relevant to babies, children, young people and adults. However, the vast majority of people requiring palliative and end of life care are older people and for this reason we would like the equality provision to mention them specifically.

We support the broad approach. However, we have a concern in relation to Third Sector bodies contracted to carry out functions of a public nature. Such contracts need to adequately reflect the resources required to realise people's rights. Resourcing and funding arrangements must be on an equal footing with statutory bodies, including sustainable, longer term funding models.

We have specific views on the minimum core obligations on the right to highest attainable standard of physical and mental health:-

We believe that palliative and end of life care should be put on an equal footing with the other priorities given specific mention in General Comment 14 of the Committee (referenced in the SG Consultation Document).

The dominant paradigms which inform both public health and healthcare policies, plans and priorities emphasise prevention, cure and longevity of life. The experience of irreversibly declining health and dying does not sit easily within this framework, which why it is essential that it be mentioned specifically, otherwise it will risk being missed by duty bearing bodies.

Over 60,000 people die in Scotland each year and 90% of people will have palliative care needs. Everyone dies. Palliative care and end of life care therefore has the characteristics of being of universal relevance and of large scale. It shares these characteristics with the other priorities which are specifically mentioned by the Treaty Body (such as reproductive care, maternal healthcare, child healthcare). It is puzzling and significant gap which is receiving significant recognition at international level.

It is not acceptable that the effective and timely treatment of distressing breathlessness, nausea and severe pain at the end of life should be left to a process of progressive realisation. Scotland is a sophisticated and relatively wealthy country capable of delivering a minimum core obligation in this area.

However, our experience of how this principle is put into practice gives us serious cause for concern. Despite best intentions it is difficult to see how people with serious illness and who those who may be dying can take part on an equal footing in any participatory process. These perspectives are consequently often marginalised or absent in public policy development.
